Galaxy Entertainment granted sole license for DEAN & DELUCA Macau First café to launch at Galaxy Macau this Fall

This agreement includes the opening of a minimum 3 café locations plus 1 market location over the terms of 10 years starting from 2017. The first café will be strategically anchoring itself at Macau’s number 1 shopping and café society destination - the Promenade Shops in Galaxy Macau™ coming this fall. After the opening of the first café, Galaxy plans to open a second 700 square meter plus market in Galaxy Mall by 2018. More cafes are in the pipeline and will happen in the course of this partnership agreement. Galaxy will have the exclusive rights to develop DEAN & DELUCA in specific parts of the People’s Republic of China as well as Macao and furthermore expect to explore other investment opportunities.
